- #1. "I MOVE A NOTICE OF MOTION TO AMEND SECTION 14.2 OF THE AMALGAMATED TRANSIT UNION (ATU) CONSTITUTION AND GENERAL LAWS TO ADD A CONFLICT OF INTEREST CLAUSE. THE PURPOSE IS TO AMEND SECTION 4 OF THE ATU LOCAL 113 BYLAWS. THIS NOTICE OF MOTION REQUIRES APPROVAL AT THE LOCAL UNION LEVEL BEFORE PROCEEDING TO INTERNATIONAL TO SEEK RESOLUTION AT THE NEXT ATU TRIENNIAL CONVENTION.

THE CONFLICT OF INTEREST CLAUSE IS TO BE ADDED TO THE LIST OF CONDITIONS TO BE ELIGIBLE TO RUN FOR AN ELECTED OR APPOINTED POSITION(S) IN THE LOCAL UNION IN SECTION 14.2. ELIGIBILITY OF LU OFFICE;

TO STATE THE FOLLOWING:

ANY MEMBER IN GOOD STANDING THAT HAS STARTED OR PARTICIPATED IN ANY OPEN AND ONGOING INDEPENDENT OR GROUP LITIGATION AGAINST THE ATU INTERNATIONAL AND OR ANY LU DURING AN ELECTION IS PROHIBITED FROM RUNNING AND ONCE LITIGATION IS CLOSED AND THEY MEET THE OTHER REQUIREMENTS TO RUN, THEY CAN DO SO AT THE FOLLOWING ELECTION IF SO INTERESTED."
